

# **Privacy Notice for Medical Information, Medicinal Products safety Service and Product Complaints**

Last updated date: 02/12/2020

AB Science ensures new product development for human and veterinary medicine and markets medicinal products for veterinary use.

Human beings and animals vary in their biological reactions to medicinal products. Capturing adverse events, in the development and marketing phases of all products, from worldwide sources is of paramount importance. Monitoring the safety of all AB Science medicines, includes adverse events reporting management, named pharmacovigilance. At the same time, AB Science may receive inquiries or product complaints from various people such as healthcare professionals, nurses, or caregivers and from patients with respect to the products.

For these purposes, our legal obligations require us to process certain received information for any reason), which allow to directly or indirectly identify a person, "Personal Data" of a patient and/or the reporter of an adverse event, and/or the inquirer of an information. The treatment of personal data in this context is performed on a voluntary basis, with the purpose of protecting public health and, in particular, ensuring the quality and safety of all AB Science products.

This Privacy Notice was developed to inform you about how AB Science respects your right to privacy and treats your "personal data" in accordance with AB Science General Privacy Policy and applicable privacy and data protection laws, including the General Data Protection Regulation (GDPR), and other applicable local laws that regulate the storage, process, access and transfer of personal data.

### What personal information does AB Science treat?

The types of information we may collect and process, will depend on the category of data subjects and/or the data processing activity. All the personal data we may collect are described in a table available at the end of this Privacy Notice and for each, the legal basis is detailed.

# How does AB Science keep my personal information secure?

We have implemented appropriate state of the art technical and organizational measures to protect the personal information that we collect and process about you. The measures we use are designed to provide a level of security appropriate to the risk of processing your personal information.

#### Who will obtain right to access to my personal data?

Your personal data will be accessible only to authorized persons, including third-party service providers, including our distribution and Information Technology systems (software) service providers. Also, AB Science is obliged to report certain pharmacovigilance and product relevant information to Health Authorities worldwide, including those with different level of data protection compared to EU. It is possible that in the exchange of data as detailed previously, your personal data may be transferred to countries that do not provide the same level of protection as your own.

Before sharing your personal data with third parties for purposes stated in this Privacy Notice, personal data will be pseudonymized where appropriate or required by applicable law.

In addition, we have taken appropriate safeguards to require that your personal information will remain protected in accordance with this Privacy Notice. If relevant, these include implementing the European Commission's Standard Contractual Clauses for transfers of personal information between our group companies, which require all group companies to protect personal information they process from the European Economic Area (EEA) in accordance with European Union data protection law.

#### How many times will my personal data be retained?

- Your contact data shall be stored for 18 months, other personal data depends on the purpose.
- We will use and store your Personal Data in accordance with mandatory legal requirements governing storage and reporting of Pharmacovigilance related information. Such mandatory requirements oblige us to archive PV information which may include Personal Data at least for the duration of the product life-cycle and for an additional ten years after the respective medicinal product and medical devices has been taken from the market.
- Personal data retained as part of a medical information inquiry are kept for minimum of 10 and maximum of 15 years after receipt.

After the expiry of the retention period, personal data will be erased, destroyed, or anonymized, without prejudice to potential data retention period provided by the law.

# What are my rights regarding data protection?

- You have the right to access, correct, or update your personal information,
- You have the right to object to processing of your personal information, or to ask us to restrict processing of your personal information or to delete your personal information, or to request portability of your personal information (request of the transfer of your personal data to you or another person in a commonly utilizable format). These rights may be limited where there is a legal ground for example, AB Science cannot delete information that has been collected as part of an adverse event report unless it is inaccurate. Similarly, if we have collected and processed your personal information with your consent, then you can withdraw your consent at any time. Withdrawing your consent will not affect the lawfulness of any processing we conducted prior to your withdrawal, nor will it affect processing of your personal information conducted in reliance on lawful processing grounds other than consent.
- You have **the right to complain** to a data protection authority about our collection and use of your personal information.

We respond to all requests we receive from individuals wishing to exercise their data protection rights in accordance with applicable data protection laws. We may require you to provide proper identification before we comply with any request to access or correct your Personal Data.
